**SECTION 4: FIRST AID MEASURES**

<b>IF IN EYES:</b>	Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.
<b>IF ON SKIN:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

**SECTION 5: FIRE-FIGHTING MEASURES**

<b>Suitable Extinguishing Media:</b>	Water fog or fine spray. Dry chemical fire extinguishers. Carbon dioxide fire extinguishers. Foam. Alcohol resistant foams (ATC type) are preferred. General purpose synthetic foams (including AFFF) or protein foams may function, but will be less effective.
<b>Unsuitable Extinguishing Media:</b>	Do not use direct water stream. May spread fire.
<b>Hazardous Combustion Products:</b>	During a fire, smoke may contain the original material in addition to combustion products of varying composition which may be toxic and/or irritating. Combustion products may include and are not limited to: Sulfur oxides. Nitrogen oxides. Hydrogen fluoride. Carbon monoxide. Carbon dioxide.
<b>Special Protective Equipment &amp; Precautions:</b>	Evacuate area and fight fire upwind from a safe distance to avoid hazardous vapors and decomposition products. Foam and/or dry chemical are preferred to minimize environmental contamination. If water is used, dike and collect water to prevent run-off. Wear self-contained breathing apparatus and full fire-fighting turn-out gear (Bunker gear).
<b>Unusual Fire &amp; Explosion Hazards:</b>	Container may rupture from gas generation in a fire situation.

Violent steam generation or eruption may occur upon application of direct water stream to hot liquids. When product is stored in closed containers, a flammable atmosphere can develop.

#### SECTION 6: ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions:</b>	See Section 8 for personal protection equipment.
<b>Environmental Precautions:</b>	Keep spilled material and any rinsate from contaminating soil or from entering sewage and drainage systems and bodies of water.
<b>Methods for Containment:</b>	Isolate the spill area and remove all sources of ignition. Keep unnecessary and unprotected personnel from entering. Absorb small spills with sand, vermiculite or other inert absorbent. Do not use combustible materials such as sawdust or cloth rags. Dike large spills using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse. Allow absorbed material to solidify and scrape up for disposal.
<b>Methods for Clean-up:</b>	Place contaminated material in appropriate container for disposal. After removal, flush contaminated area thoroughly with water. Pick up wash liquid with additional absorbent and place in a disposable container. Do not put spilled material back in the original container.
<b>Other Information:</b>	This product contains cyclohexanone and spills may require reporting under Federal, state or locals laws and regulations.

#### SECTION 7: HANDLING AND STORAGE

<b>Handling:</b>	RECOMMENDATIONS ARE INTENDED FOR MANUFACTURING, PACKAGING AND COMMERCIAL BLENDING WORKERS.
