SECTION 4: FIRST AID MEASURES	
<b>IF IN EYES:</b>	Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.
<b>IF ON SKIN:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
<b>IF INHALED:</b>	Move person to fresh air. If person is not breathing, call 911 or an ambulance; then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

**SECTION 5: FIRE-FIGHTING MEASURES**

**Suitable Extinguishing Media:** Water spray, alcohol-resistant foam, dry chemical or carbon dioxide  
**Unsuitable Extinguishing Media:** Water jet as it may spread fire.  
**Hazardous Combustion Products:** Thermal decomposition may produce toxic carbon, nitrogen and sulfur oxides.  
**Special Protective Equipment & Precautions:** Evacuate area and fight fire upwind from a safe distance to avoid hazardous vapors and decomposition products. Foam and/or dry chemical are preferred to minimize environmental contamination. If water is used, dike and collect water to prevent run-off. Wear self-contained breathing apparatus and full fire-fighting turn-out gear (Bunker gear).

**Environmental Precautions:** Keep spilled material and any rinsate from contaminating soil or from entering sewage and drainage systems and bodies of water.  
**Methods for Containment:** Isolate the spill area. Keep unnecessary and unprotected personnel from entering. Recover and contain as much free granules as possible for re-use.  
**Methods for Clean-up:** Shovel or sweep up spilled granules. Avoid dust formation. Place recovered material in a separate container for re-use. After removal, flush contaminated area thoroughly with soap and water. Pick up wash liquid with additional absorbent and place in a disposable container. Do not put spilled material back in the original container.

**Handling:** RECOMMENDATIONS ARE INTENDED FOR MANUFACTURING, PACKAGING AND COMMERCIAL BLENDING WORKERS. **SECTION 12: ECOLOGICAL INFORMATION**

**Environmental Hazards Statement from FIFRA Regulated Pesticide Label:**

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply where runoff water may flow during periods of intense rainfall or to water-saturated soils, as off-target movement and injury may occur. Do not contaminate water when cleaning equipment or disposing of equipment washwaters or rinsate.

Metsulfuron methyl is known to leach through soil into groundwater under certain conditions as a result of label use. This chemical may leach into groundwater if used in areas where soils are permeable, particularly where the water table is shallow.

This product may impact surface water quality due to runoff of rain water. This is especially true for poorly draining soils and soils with shallow ground water. This product is classified as having high potential for reaching surface water via runoff for weeks after application. A level, well-maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential loading of Metsulfuron methyl from runoff water and sediment. Runoff of this product will be greatly reduced by avoiding applications when rainfall or irrigation is expected to occur within 48 hours.
