# DIRECTIONS FOR USE SHAKE WELL!

FOR ALL TURF TYPES: Apply at a rate of 16-24 ounces per 1,000 sq. ft. every 4-6 weeks when turf is actively growing. Apply during the growing season.

Backpack/Pump Sprayer: Mix 16oz N-Charge per 2 gallons of water. NOTE: Water lawn for 5 minutes after application for best results.

### **Hose End Sprayer:**

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn

Storage: Store in a cool dry place away from direct sunlight. Product will store for 2 years under warehouse conditions. Protect from freezing. Observe any State or Local fertilizer application regulations. Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden. Apply only to turf and soil. Caution:
