## DIRECTIONS FOR USE: SHAKE WELL!

**TURF:** Can be applied as often as monthly during growing season. Apply in spring or fall; however, liquid aeration can be done anytime during the growing season. Apply **N-Ext Air-8** at a rate of 6-9 ounces per 1,000 sq. ft. with 1 gallon of water. Product is safe for use on all turf types and ornamental plants.
