Backpack/Pump Sprayer:

Applying Weekly: Mix 6 oz **N-Ext D-Thatch** per 1 gallon of water.

Applying Bi-Weekly: Mix 9 oz **N-Ext D-Thatch** per 1 gallon of water.

NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn
