DIRECTIONS FOR USE: SHAKE WELL!

TURFGRASS: Can be applied as often as monthly during growing season. Apply up to 3-6 ounces of 0-0-2 MicroGreene diluted with a minimum of 1 quart of water per 1,000 sq. ft.

PLANTS, TREES AND SHRUBS: Can be applied as often as monthly during growing season. Mix 1-2 ounces of 0-0-2 MicroGreene in minimum of 1 quart of water and apply to foliage and/or soil. Do not over-water. Product is safe for use on all turf types and ornamental plants.

Backpack/pump sprayer: Mix 6oz MicroGreene per 1/2 gallon of water.

NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn
