Backpack/Pump Sprayer:

Mix 16oz N-Charge per 2 gallons of water.

NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn
