## **DIRECTIONS FOR USE:**

#### SHAKE WELL!

FOR ALL TURF TYPES: Apply at a rate of 8 ounces per 1,000 sq. ft.every 2-4 weeks when turf is actively growing. Apply directly to foilage.

Backpack/Pump Sprayer: Mix 8oz GreeneEfFect per 1 gallon of water. NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through
  the lawn
- Set to 4oz if moving quickly through the lawn
