



#### **DIRECTIONS FOR USE: SHAKE WELL!**

TURF: Can be applied as often as monthly during growing season. Apply in spring or fall; however, liquid aeration can be done anytime during the growing season. Apply N-Ext Air-8 at a rate of 6-9 ounces per 1,000 sq. ft. with 1 gallon of water. Product is safe for use on all turf types and ornamental plants. Product is intended to be used as an additive to current fertilizer program.

Backpack/pump sprayer: Mix 6oz N-Ext Air-8 per 1 gallons of water. NOTE: Water lawn for 5 minutes after application for best results.

## Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn
