DIRECTIONS FOR USE: SHAKE WELL!

TURF GRASS: Apply at a rate of 6-9 ounces per 1,000 sq. ft. with 1 gallon of water.

Backpack/Pump Sprayer: Applying Weekly: Mix 6 oz N-Ext D-Thatch per 1 gallon of water.

Applying Bi-Weekly: Mix 9 oz N-Ext D-Thatch per 1 gallon of water.

NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn
