Do not apply when daytime temps are above 85 degrees

Turf: Can be applied as often as monthly during growing season.

Do not exceed label rate. Apply no more than 1/2 ounce of N-Ext Sea-K™ diluted with a minimum of 1/2 gallon of water per 1,000 sq. ft.

Backpack/pump sprayer: Mix 1oz N-Ext Sea-K per 1 gallon of water. NOTE: Water lawn for 5 minutes after application for best results.

Hose End Sprayer:

- Set to 2oz if moving slowly through the lawn
- Set to 4oz if moving quickly through the lawn

Plants and Shrubs: Can be applied as often as monthly during growing season. Do not exceed label rate. Mix up to 1 ounce of N-Ext Sea-K™ in 1 gallon of water and apply to foliage and/or soil.
