PRO DIRECTIONS

Greens, Tees, Fairways, Lawns and Sports Turf Localized Dry Spots and Water Repellency Conditions

Apply as a preventative program:

Apply at 4 to 6 ounces per 1,000 sq. ft. every 6 to 8 weeks. Apply at least two times.

If drought conditions are present:

Apply at 6 to 8 ounces per 1,000 sq. ft. every 6 to 8 weeks. Apply at least two times.

For a spot treatment strategy:

Apply at 2 to 4 ounces per 200 sq. ft. every 4-6 weeks to treat for existing localized dry spots. Apply at least two times.

Product is safe for use on all turf types.

PRODUCT DESCRIPTION

Hydr8 EXT™ 100% Alkoxylated Polyols. This is the solution for up to 45-day protection for lawns, commercial property applications before the onset of drought or dry conditions.

Applications can be made via commercial tank sprayers, ride-on spreader/sprayers hose end and pump sprayers.

STORAGE AND DISPOSAL: Store in a safe manner. Store in original labeled container only in a cool place away from direct sunlight. Protect from freezing. Keep tightly sealed when not in use. Keep in a secure and locked storage area. Do not add water to the contents of this container. Triple rinse container, empty rinse water into spray or stock tank. Store product and dispose of unused product and empty containers in accordance with federal, state and local regulations. APPLY in accordance with best management practices (BMP's) established by your Cooperative Extension Service. Follow state application rates for your turf type unless otherwise directed. Do not apply near water storm drains or drainage ditches. Do not apply if heavy rain is expected. CAUTION: apply only to turf and plants. KEEP OUT OF REACH OF CHILDREN.
