PRO DIRECTIONS

SHAKE WELL! The mixed product should be agitated prior to and during application.

Tank Mixing: Apply at a minimum rate of 6 ounces per 1,000 sq. ft. and a maximum rate of 9 ounces per 1,000 sq. ft. Dilute with enough liquid to cover 1 acre. Do not apply with less than 7:1 dilution with water. Apply in spring or fall; however, liquid aeration an be done anytime during the growing season.

Product is safe for use on all turf and soil types. Product is intended to be used as an additive to current fertilizer program.

Mixing with Fertilizers: N-Ext AIR-8™ PRO can be mixed with liquid fertilizers. Apply in this order: 1) Water; 2) N-Ext Air-8™ PRO, 3) Water Soluble or Liquid Fertilizer.

Mixing with Pesticide, Herbicide or Fungicide: **N-Ext AIR-8™ PRO** can be mixed with pesticides, herbicides and fungicides and applied. We recommend the following: Use the product within 24 hours of mixing products (especially with fungicides). Do not over-apply pesticides, herbicides or fungicides as they can have an adverse effect on the populations of soil organisms.

Storage: Store in a cool dry place away from direct sunlight. Product will store for 2 years under warehouse conditions. Protect from freezing. Apply in accordance with best management practices (BMP's) established by your Cooperative Extension Service. Observe any State or Local fertilizer application regulations. Caution: Apply only to turf, plants, and soil. Keep out of reach of children.
